Please discuss with staff or a board member if you have questions. **You must fill out this portion of the Dues Statement even if you are already enrolled in ACH payments from the prior year.**

If the calculated monthly ACH amount does not cover the entirety of dues by 12/31/2026, a representative of the Belleville Country Club will reach out to discuss a change in the monthly payment amount to ensure dues are paid in full by the end of the year.

I understand that this authorization will remain in effect for up to 12 months (to cover 1 full year of dues) and will remain in effect the following year unless I cancel it in writing. I agree to notify the Belleville Country Club in writing of any changes in my account information at least 15 days prior to the next billing date. If the 20th falls on a weekend or holiday, the payment will be executed on the next business day. I understand that because this is an electronic transaction, these funds will be withdrawn from my account on the 20th, (except weekends or holidays as stated.) In the case that the ACH transaction is rejected for non-sufficient funds, I understand the Belleville Country Club may at its discretion attempt to process the charge again within 30 days and I agree to a \$25 charge for each attempt returned NSF which will be initiated as a separate transaction from the authorized recurring payment. I acknowledge that the origin of the ACH transaction to my account must comply with the provisions of the U.S. Law.
